### **COURSE DESCRIPTION**

Application of communication theory and practice to the public speaking context, with emphasis on audience analysis, speaker delivery, ethics of communication, cultural diversity, and speech organizational techniques to develop students' speaking abilities, as well as ability to effectively evaluate oral presentations.

### **COURSE OBJECTIVES**

Upon completion of this course, the student will be able to

- 1. Demonstrate an understanding of the foundational models of communication.
- 2. Apply elements of audience analysis.
- 3. Demonstrate ethical speaking and listening skills by analyzing presentations for evidence and logic.
- 4. Research, develop and deliver extemporaneous speeches with effective verbal and nonverbal techniques.
- 5. Demonstrate effective usage of technology when researching and/or presenting speeches.
- 6. Identify how culture, ethnicity and gender influence communication.
- 7. Develop proficiency in presenting a variety of speeches as an individual or group (e.g. narrative, informative or persuasive).

    - iv. Speech video
  - 2. Student speech videos must clearly show the front of the student. Failure to do so will result in a zero.
  - 3. Videos must be unedited. Edited videos will result in a zero.
- 4. You should dress professionally and have an appropriate background. Please do not deliver speeches sitting on your bed.
- 5. Videos must be correctly uploaded to YouTube with an "unlisted" or "public" privacy setting. If you set it to "private" I will not be able to view it and therefore it is as if you didn't turn it in. Videos not uploaded to YouTube will receive a zero.
- 6. Videos must be focused (not blurry, fuzzy, etc.) and must not have background noise such as babies, children, pets, TVs, cell phones, etc.
- 7. Speeches should not include media with other people talking; this does not count as a visual aid, and points will be deducted at a high manner for doing this.
