COURSE DESCRIPTION

A study of analyzing, classifying, and recording business transactions in a manual and computerized environment. Emphasis on understanding the complete accounting cycle and preparing financial statements, bank reconciliations, and payroll.

Upon completion of this course, the student will be able to

- Define accounting terminology
- Analyze and record business transactions in a manual and computerized environment
- Complete the accounting cycle; prepare financial statements
- Apply accounting concepts related to cash and payroll
- Prepare bank reconciliations
- Correct accounting errors
