Additional Course Policies/Information

- 1. Coming to class prepared is your ticket into the classroom. *Being prepared is defined as having the following:* textbook, notebook, pen/pencil, paper, calculator, and completed assignments (such as study questions).

- 4. <u>Academic Integrity</u>: It shall be considered a breach of academic integrity (*cheating*) to Use or possess on your body any of the following devices during any examination unless It is required for that examination and approved by the instructor: cell phone, smart watch/ Watch phone, laptop, tablet, electronic communication devices (including optical) and Earphones connected to or used as electronic communication devices.

- 5. **Attendance.** Perfect attendance means not missing any classes or any portion of a class. This includes not having any tardies or leaving class early.
