<u>Plagiarism:</u> Academic honesty is expected on all assignments. All work submitted must be your own work. Plagiarism must be avoided. Clearly cite references when using another's ideas and use MLA 8TH edition format for referencing both in the body of a paper and in the reference section. All work must be submitted to the Safe Assign program in Blackboard to be reviewed for plagiarism. Students who plagiarize (use the work of others without giving credit to the original author) will receive a grade of zero on the assignment.

<u>MLA Formatting:</u> Students must follow the formatting rules of MLA 8th edition to succeed in this course. Formatting includes: a cover page, headings, page numbers, in-text citations, and works cited. All written assignments must be typewritten on white 8.5x11 paper in 12-point Times New Roman font and double spaced. Also, I refer students to the OWL@purdue for all questions regarding MLA that have not been covered in other materials.

File Formats: All documents must be saved in one of the following file formats: .doc or .docx. I will not accept documents in any other format. <u>Late Work:</u> I expect all assignments to be turned in on time, by 11:59 pm of the due date, usually Sunday, the last day of the weekly unit. Ideally, you should submit assignments early to avoid potential submission issues.

No work can be submitted late without my approval:
