# **COURSE DESCRIPTION**

A general introduction to the visual arts designed to create an appreciation of the vocabulary, media, techniques, and purposes of the creative process. Students will critically interpret and evaluate works of art within formal, cultural, and historical contexts.

- Differentiate between the processes and materials used in the production of various works of art

Unless otherwise specified, each assignment must be uploaded to the appropriate Blackboard link by 11:59 pm on the due date. Assignments turned in after the due date will be considered late. If such assignments are accepted, it will be solely at the instructor's discretion and with an automatic point reduction penalty.

Be respectful of your instructor's time and turn in all assignments by or before the appropriate due date. Plagiarized or academically dishonest assignments will result in an automatic zero.

If a student fails a major assignment barring the final project, or does not turn in a major assignment on time, the student will have three business days from when the initial grade is entered to contact the professor and submit a redo.
