- **RECOMMENDED** for students scoring a Level 5 ABE or Level 6 ABE on the TSI-Assessment.

Must be co-enrolled in TMTH 375 Developmental Mathematics

TMTH 0165 is the co-requisite to TMTH 375.

All students enrolled in TMTH 165-3B1 must be enrolled in TMTH 375-3B1.

COURSE DESCRIPTION

Topics include the study of functions, inequalities, algebraic expressions and equations (absolute value, polynomial, radical, and rational), with a special emphasis on linear and quadratic expressions and equations. This course must be taken concurrently with TMTH 0375 section 3B1 (Intermediate Algebra). It will serve to provide additional time for the student to receive one-on-one support. Intervention will be provided by the instructor of record.

COURSE OBJECTIVES

Upon successful completion of this course, students will be able to

1. Define, represent, and perform operations on real and complex numbers.
2. Identify and solve linear, absolute value, and quadratic equations.
3. Identify and solve absolute value and linear inequalities.
4. Recognize and use algebraic properties, concepts, and procedures (including factoring) to combine, transform, and evaluate polynomial expressions.

Graph absolute and linear inequalities, use interval notation.
