COURSE DESCRIPTION

Methods used in the identification of physical, emotional, and sexual abuse and neglect with an emphasis on developing skills for working with children and families. Includes methods of referral to public and private agencies that deal with investigation and treatment.

COURSE OBJECTIVES

Upon completion of this course, the student will be able to

- Identify the physical and behavioral signs of child abuse and neglect in infants, toddlers, preschoolers, school-agers.
- Define your legal and ethical responsibility for reporting suspected abuse and neglect.
- Apply strategies to take care of yourself after reporting suspicions of abuse and neglect.
- Implement ways to support children and families affected by abuse and neglect.
- Understand program features and policies that protect children from harm in your program.
- Identify methods of referral to public and private agencies that deal with investigations and treatments.

CORE OBJECTIVES

Objective 1: Demonstrate knowledge of the physical and behavioral signs of child abuse and neglect in children of various ages (infants, toddlers, preschoolers, school-agers).

Objective 2: Define legal and ethical responsibilities related to the reporting of suspected child abuse and neglect.

Objective 3: Understand program features and policies designed to protect children from harm.

Objective 4: Identify available resources and referral methods to public and private agencies that handle investigations and treatment of child abuse and neglect.

Objective 5: Apply strategies for self-care after reporting suspected child abuse and neglect.

Objective 6: Implement ways to support children and families affected by abuse and neglect within program guidelines.

REQUIRED TEXTBOOK AND MATERIALS
