COURSE DESCRIPTION

A survey of the social, political, economic, cultural, and intellectual history of the United States from the Old West era to the end of the Cold War. United States History II examines industrialization, immigration, world wars, the Great Depression, Cold War and post-Cold War eras. Themes that may be addressed in United States History II include American culture, religion, civil and human rights, technological change, economic change, immigration and migration, urbanization and suburbanization, the expansion of the federal government, and the study of U.S. foreign policy.

Upon completion of this course, the student will be able to

1. Create an argument through the use of historical evidence.
2. Analyze and interpret primary and secondary sources.
3. Analyze the effects of historical, social, political, economic, cultural, and global forces on this period of United States history.

To prepare students for their selected careers, LIT desires to guide students in the ethical use of these technologies and incorporate AI into classroom instruction and assignments appropriately. Appropriate use of these technologies is at the discretion of the instructor. Students are reminded that all submitted work must be their own original work unless otherwise specified. Students should contact their instructor with any questions as to the acceptable use of AI/ChatGPT in their courses

For this course, AI is strictly prohibited **with the sole exception** of assignments where the use of such tool is indicated as required by the course instructor. The goal of a writing assignment is to develop the authorial voice and critical thinking skills of the student and offloading that responsibility entirely to an AI completely misses the purpose of a writing assignment and raises serious questions about plagiarism. To this end, all written submissions in this course **are required** to be composed in Google Docs, which will be submitted with any unproctored written assignment to the course instructor, following the procedures outlined in Blackboard. Any submissions that appear to have been generated via AI will be flagged by the instructor, and a temporary grade of zero may be applied until the instructor can thoroughly investigate the matter. Once a final determination is reached, the instructor will assign a permanent grade (depending on the outcome of the investigation). A first-time offense will result in a warning, but a second offense will result in the student's failure in the class.

STARFISH

LIT utilizes an early alert system called Starfish. Throughout the semester, you may receive emails from Starfish regarding your course grades, attendance, or academic performance.
