- Critical Thinking Analysis – Analyzation of current and or past criminal cases of deviance using the Scientific Theory of understanding of what is deviant behavior, deviance of violence, self destructive deviance (suicide and mental disorder(s) ) diverse lifestyles, substance use and abuse and internet deviance. - Research and Practical Application Project – Students will research a past felony deviant crime issue / topic of their choice and write a summary of the crime , criminal and specific deviance to include the who, when, what why and how of the criminal event(s).
- Exams – There will be three exams and a Final Exam. Each exam will cover 3-4 chapters of the text. Each Exam will cover specific Learning Objectives that are discussed in each period of instruction (Deviance defined / Theories of Deviance / Physical Violence / Self Destructive Deviance / Substance Abuse / Internet deviance.
- All Assignments must be submitted on line blackboard during the designated time period(s).

Activities consist of class assignments, individual analysis of information from various sources including the text and power point presentations.
