COURSE DESCRIPTION

In-depth coverage of electronic systems, maintenance, troubleshooting, and repair. Topics include symptom identification, proper repair procedures, repair checkout, and preventative maintenance. Emphasis on safety and use of test equipment.

Upon completion of this course, the student will be able to

- Explain the purpose and application of electronic troubleshooting.
- Identify and utilize test equipment for problem analysis.
- Find test point locations from schematics or prints
- Isolate faults and repair, perform routine maintenance.

II. Absences are counted for unexcused, excused and coming to class late.

- C. If you sleep in class, you will be counted absent.

IV. **Excused absences.** Only given to allow students to make up missed work.

- A. Will be given for documented Injury or Illness. The doctor's excuse required showing proof. Will count toward total days missed.
- B. Will be given for documented Death in immediate family. Will count toward total days missed.
- C. Approved LIT school functions; E.g., SkillsUSA, SGA etc. Will not count toward total days missed
- D. It is the student's responsibility to obtain from the instructor any handouts or assignments for classes missed. Lectures will not be repeated.

DROP POLICY
