### COURSE DESCRIPTION

Study of electric distribution line construction. Includes reading staking sheets and framing specifications, tailboard discussions, pole framing and setting, installing conductors, transformers and other line equipment, and OSHA and NESC regulations.

### COURSE OBJECTIVES

Upon completion of this course, the student will be able to:

List equipment and material needed from staking sheet information; describe safe work procedures and tailboard discussion; define framing specifications; and demonstrate pole framing. Demonstrate pole setting procedures, conductor and equipment installations; and all relevant safety rules and procedures.
