COURSE DESCRIPTION

A study of the theoretical practice, and practical procedures utilized in distribution line maintenance. Topics include voltage conversion, reconductoring energized circuits, pole change-outs, resagging energized conductors, and lockout-tagout procedures.

Upon completion of this course, the student will be able to:

Determine equipment and materials need from staking sheet information. Perform safe work procedures and hold tailboard discussions. Perform pole change out procedures on energized circuits. Perform voltage conversion procedures. Perform procedures for changing out pole line equipment. Apply and follow all relevant safety rules and procedures.
