Nurse Aide for Health Care (NURA 1301)



Credit: 3 semester credit hours (2 hours lecture, 2 hours lab)

Co-requisite: NURA 1260

Course Description

Knowledge, skills, and abilities essential to provide basic care to residents of long-term care facilities. Topics include resident's rights, communitcation, safety, observation, reporting and assisting residents in maintaining basic comfort and safety. Emphasis on effective interaction with members of the health care team.

- 4. No late assignments will be accepted.
- 5. Tests. Students that miss a test are not allowed to make up the test. Students that miss a test will receive a grade of '0'.
- 6. Attendance Policy. Two absences are allowed. If a student is tardy to class or departs early three (3) times, it will be equal to one (1) absence. Each absence beyond two absences will result in a 5 point deduction from your final grade.
- 7. If you wish to drop a course, the student is responsible for initiating and completing the drop process. If you stop coming to class and fail to drop the course, you will earn an 'F' in the course.

Examination Policies

1. All exams will be on the dates specified unless the instructor makes a change.

2. In case of an absence on exam day, the exam must be completed on the day the student returns to class or a grade of zero will be given for that exam. All make up exams will have a ten point penalty deducted for the first make up test, a 20 point deduction for the second make up test, a 30 point deduction for the third, 40 points deducted for the fourth, and a 50 point deduction for the fifth exam missed and made up. There will be NO make up for the Final Exam!!!
