### Course Description

Disaster scene control involving large numbers of casualties and fatalities; coordination of the responding agencies. Includes observation and critique of mass casualty disaster drills and critical incident stress debriefing. *This course is time-bound, structured, and completed totally online.*

### Course Objectives

Upon completion of this course, the student will be able to:

1. Describe the implementation of the incident management system at a mass casualty/fatality incident;
2. Identify the psychological problems that occur during a mass casualty/fatality incident;
3. Describe the symptoms of post-traumatic stress;
4. Explain how emergency workers can reduce stress;
5. Conduct a mock critical incident stress debriefing;
6. Explain the importance of critical incident stress debriefings.
7. Understand the implementation of Alternate Care Site, Medical Surge and Strategic National Stockpile distribution plans in responding to mass casualty incidents.
