



Final Project – Advanced Drafting (DFTG 2338)

Credit: 3 semester credit hours (2 hours lecture, 4 hours lab)

Prerequisite/Co-requisite: ARCE 1315

Course Description

A drafting course in which students participate in a comprehensive project from conception to conclusion.
