### **COURSE DESCRIPTION**

Fundamental elements associated with emergency medical services to include preparatory practices, pathophysiology, medication administration, and related topics.

### **COURSE OBJECTIVES**

Upon completion of this course, the student will be able to

- Demonstrate universal precautions and body substance isolation (BSI) procedures during patient contact.
- Demonstrate how to secure a patient with a suspected spinal injury who was found in a sitting position.
- Demonstrate how to secure a patient with a suspected spinal injury to a long backboard.

- Demonstrate the care of musculoskeletal injuries.
- Demonstrate how to apply a rigid splint.
- Demonstrate how to apply a traction splint.
- Demonstrate how to control bleeding from an open soft-tissue injury.
- Demonstrate how to administer medication using an intranasal atomizer.
- Demonstrate how to administer medication using a small-volume nebulizer.
- Demonstrate how to perform on and two rescuer adult, child, and infant CPR.
- Demonstrate how to obtain a 12-lead ECG tracing.
