## **COURSE DESCRIPTION**

Origin and development of the Texas constitution, structure and powers of state and local government, federalism and inter-governmental relations, political participation, the election process, public policy, and the political culture of Texas.

#### **COURSE OBJECTIVES**

Upon completion of this course, the student will be able to

- 1. Explain the origin and development of the Texas constitution.
- 2. Describe state and local political systems and their relationship with the federal government
- 3. Describe separation of powers and checks and balances in both theory and practice in Texas
- 4. Demonstrate knowledge of the legislative, executive, and judicial branches of Texas government
- 5. Evaluate the role of public opinion, interest groups, and political parties in Texas.
- 6. Analyze the state and local election process.
- 7. Identify the rights and responsibilities of citizens.
- 8. Analyze issues, policies and political culture of Texas.
