Retention Initiatives:

The Teaching and Learning Center is hosting Hobsons Starfish Enterprise Solutions on March 19-20. The visit will be led by Beth Davis, Co-Founder and Managing Director of Predictive Analytics Reporting (PAR) Framework. Beth is a leader in higher education with experience building national scale initiatives establishing communities of practice among colleges and universities. In preparation for LIT's Starfish upgrade, Davis and her team of consultants will meet with various groups of stakeholders (administrators, faculty, frontline staff) from departments across the institution to discuss ways to better support our student success efforts and assist in the development of new processes to engage students.

Grants:

Texas Mutual Insurance Company has once again awarded LIT \$100,000 for our safety institute to provide workplace safety courses for local employers, workers and the general public.



Spring Enrollment is Up 4.0%:

As of March 2, for the Spring 2018 semester, LIT has an enrollment of 2,675 (unduplicated) credit students, which represents a 4.0% (n=103) increase when compared to the same point in time last year.
